## **Research Projects**

The thesis taken up for my Doctoral programme is aimed at understanding and assessing the changing agrarian economy in rural West Bengal. 200 farming households have been surveyed through in-depth face-to-face interview to analyse the socio-economic condition in the rural economy of the state.

The dissertation was taken to analyse the nature of change that has taken place in different forms of agrarian economies. The dissertation was completed through a review of existing literature on several field-based evidences of changing caste and class relations and the dynamics of the role played by the political parties and the government as important agencies in the rural transition.
